


Paterson Non-Fatal Shootings

From January 1, 2017- September 30, 2017 The City of Paterson is experiencing a 13% decrease in Non-Fatal shootings compared to the same time period in 2016 (52 incidents 2017 vs. 60 incidents 2016).

Passaic County (all municipalities) is experiencing an overall decrease of 22% regarding non-fatal shootings from January 1, 2017-September 30, 207 compared to the same time period in 2016 (53 incidents 2017 vs. 68 incidents 2016)


From January 1, 2017- September 30, 2017 there have been 66 non-fatal shooting victims in the City of Paterson. 85% were male vs.15% female (56 male victims vs.10 females).


From January 1, 2017-September 30, 2017 there have been 67 non-fatal shooting victims in the County of Passaic (66-victims in the City of Paterson and 1-victim in the City of Passaic).

In 2016 (January 1, 2016- December 31, 2016) there were a total of 74 non-fatal shooting incidents in the City of Paterson.

In 2016 (January 1, 2016-December 31, 2016) there were a total of 78 non-fatal shootings in Passaic County. (74 in the City of Paterson and 4 in the City of Passaic).

From January 1, 2017-September 30, 2017 the City of Paterson is experiencing a 5% decrease in homicides compared to the same time period in 2016 (17 incidents 2017 vs. 18 incidents 2016).

Passaic County (all municipalities) is experiencing an overall increase of 10% regarding homicides from January 1, 2017-September 30, 2017 (20 incidents 2017 vs. 18 incidents 2016).

From January 1, 2017-September 30, 2017 there has been one (1) homicide that occurred in Wayne, one (1) homicide that occurred in Ringwood and one (1) homicide that occurred in the City of Passaic.

In 2016 (January 1, 2016-December 31, 2016) there were a total of 20 homicides that occurred in Passaic County all of which occurred in the City of Paterson.

***Note these statistics do not include non-fatal and fatal shootings that involve members of Law Enforcement.
