QUALIFICATIONS

Candidates filing a nominating petition for board membership must meet the following qualifications:

- He/she is citizen of the United States of America.
- He/she must be at least eighteen (18) years of age to qualify for office.
- He/she must be able to read and write.
- He/she has been a resident of the municipality from which he/she is to be elected for at least one year preceding the date of the election.
- He/she is not disqualified as a voter pursuant to R.S. 19:4-1.
- He/she is not disqualified from membership for the conviction of crimes pursuant to N.J.S.A.18A:12-1
- He/she is a registered voter in the district.

Completed nominating petitions shall be filed with the **Passaic County Clerk's office** on or before 4:00 pm **of the last Monday in July preceding the November School Election.** The Passaic County Clerk's office is located at 401 Grand Street, Room 130 Paterson, New Jersey business hours are Monday-Friday between 8:30 a.m. and 4:30 p.m. Phone number is 973-881-4127 ext. 2235
