Update, April 15, 2021

Please Note: This Update is posted on the Passaic County website, the Passaic County Facebook page, distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

This Update is written to provide the results from staff testing on April 14, 2021. 435 staff were tested on-site with antigen tests. The result for one nurse was positive. Prior to the test, the nurse last worked on 2-400 "B" section on April 12, 2021 with our residents with tracheostomies. Residents were placed on quarantine for 14 days. We currently have eight staff who are positive out of work.

We received all results from resident testing on April 12 through April 14, 2021. The results were negative. Currently, we do not have any residents who are positive for COVID-19. Effective April 19, 2021, residents will be tested as follows:

- Monday: 1-300, 2-300, Pathway and 1-400
- Tuesday: 1-200 and 2-200
- Wednesday: 3-400, 2-400 and Vent
- Thursday: 3-200

Healthcare Decision Day is on April 16, 2021. This national day is established to promote the importance of advance care planning and encourage people to express their wishes regarding healthcare and to document their wishes in an advanced care plan.

As of April 15, 2021, we can offer outdoor visitation (for all units except the 2-400 Observation Unit and 2-400 Respiratory/trach), compassionate care visits and end of life visitation.
